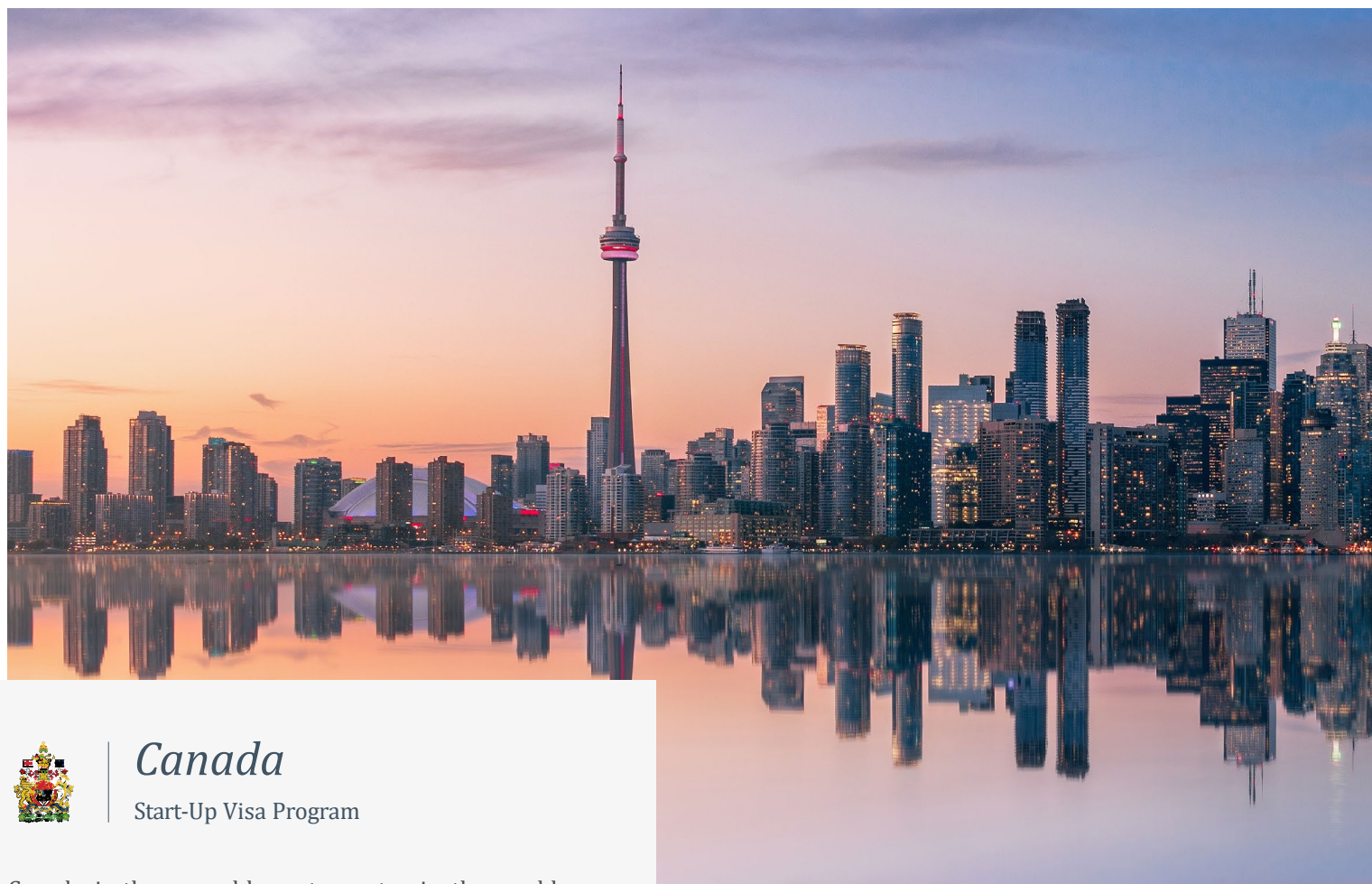

## Procedures

Clients are required to prepare and submit a business proposal, which needs to be approved by a designated government business organization. Once approved, you will receive a letter of support, allowing you and your family to apply for permanent residence. In order to maintain permanent resident status, physical presence for two out of five years (or 730 days) in Canada is required.

## Main applicant requirements

-  English or French language proficiency at the CLB/IELTS 5 level
-  Good health
-  No criminal record

In addition, applicants are required to propose an innovative, scaling start-up business, approved by a designated organization

Choose one of the following three options:

-  *Business incubation*  
No minimum investment required
-  *Angel investment*  
Raise CAD 75,000 from an angel investment group, depending on a certain stage of the business
-  *Venture capital fund*  
Raise CAD 200,000 from a venture capital fund, depending on a certain stage of the business

For the three options above, additional fees apply for optional consulting, government fees, business structure, document processing, and immigration filing.

- Minimum investment of CAD 1.2 million

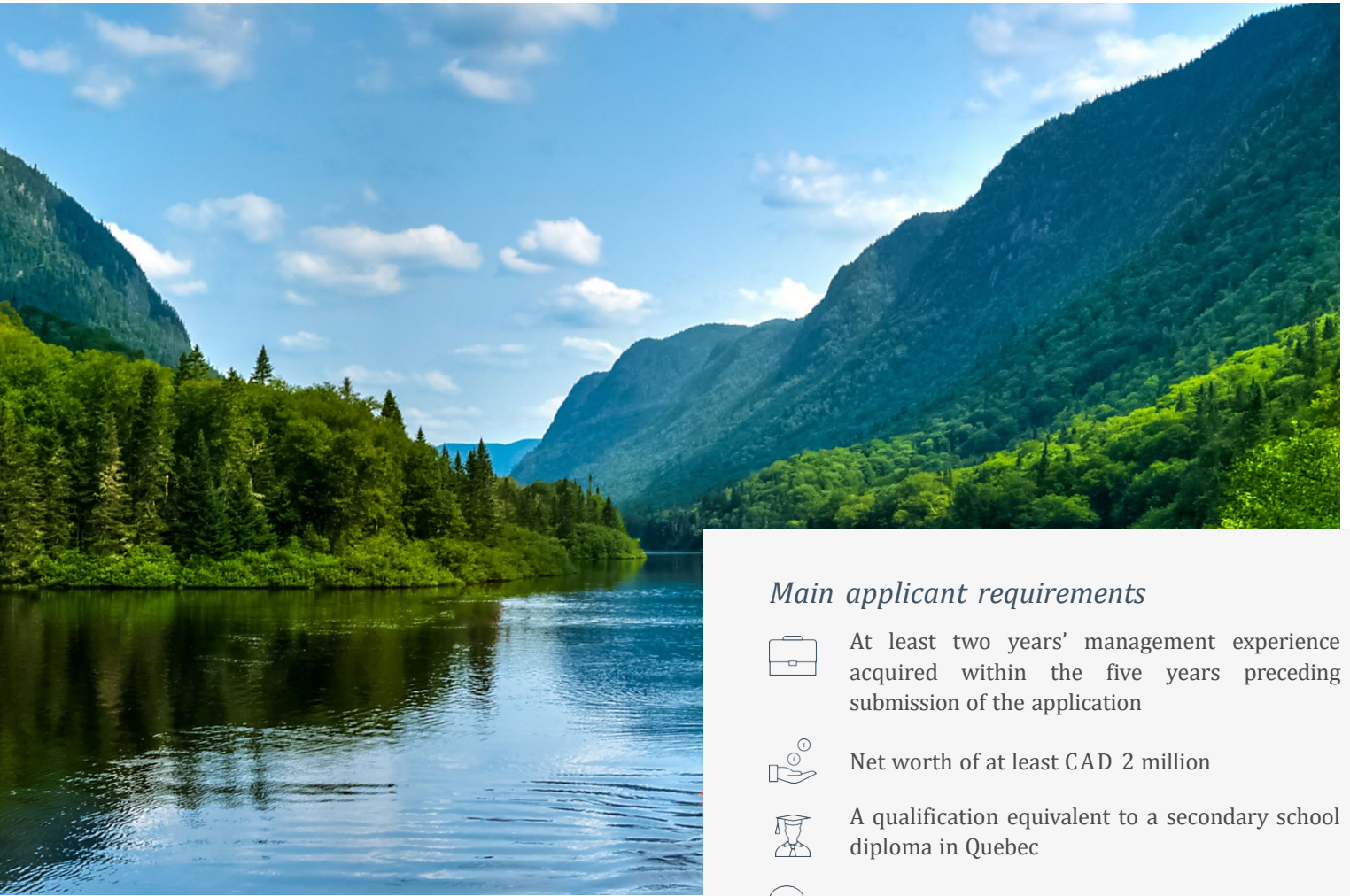

After permanent residence is granted, eligibility for citizenship after three years (or 1,095 days) of physical presence out of a five-year period









## Procedures



A minimum stay of at least 12 months within two years following issuance of the work permit is required. At least six months of the stay must be completed by the main applicant and the remaining six months can be completed by the main applicant or their spouse. In order to maintain permanent resident status, physical presence for two out of five years (or 730 days) in Canada is required.

## Main applicant requirements

-  At least two years' management experience acquired within the five years preceding submission of the application
-  Net worth of at least CAD 2 million
-  A qualification equivalent to a secondary school diploma in Quebec
-  Proficiency in spoken French of at least level 7

Applicants are also required to make the following investments:

-  Five-year interest-free investment of CAD 1 million. The investment is guaranteed by the Government of Quebec.
-  Non-refundable contribution of CAD 200,000 to Investissement Québec.
